New Business:

The trustees signed one purchase order, reviewed the bank statements, management reports, and signed cemetery deeds.

The Fiscal Officer informed the trustees that The Savings Bank will be updating its system with new software on August 11th.

Jeff Wippel mentioned that the crack seal road project has been completed and that he has inspected and approved the project for payment.

Ronald Clifton stated that the Dollar General Store that wants to build across the road from Westfall Schools is pending. Feedback from Township residents has not been positive.

The trustees reviewed current fire runs and noticed that Westfall Schools has had dropped alarms due to having work crews in the buildings. Ronald Clifton will discuss with Westfall.

The trustees reviewed and approved the new 2024 fire contract with Southwest Pickaway Fire District. Stan Summers made the motion to approve, seconded by Jeff Wippel, motion passed with three yeas.

Dave Cline addressed the trustees about installing a Columbarium in the cemetery. The trustees asked Mr Cline to put together an itemized quote and submit it to the board for review. The trustees discussed the pros and cons and placement of a columbarium. Stan Summers will ask Wellmans for an itemized quote as well so the trustees can compare what all is involved.

Being there was no further business to discuss, Stan Summers moved, seconded by Jeff Wippel to adjourn the meeting. The motion passed with three yeas.
